**Prof. Dr. Davor Babić, LL.M. -** Associate Professor at the Private International Law Department, Faculty of Law, University of Zagreb. His academic interests are related to private international law, international arbitration, international investment law and alternative dispute resolution. Prof. Dr. Davor Babić headed the working group for Chapter 6 (EU Company Law) in Croatia's accession negotiations with the European Union. He served as the Secretary of the Permanent Arbitration Court at the Croatian Chamber of Commerce. He is active as an arbitrator in commercial cases before various regional and international arbitral institutions. He is a member of the ICC Commission on Arbitration and ADR.

**Emilia Fronczak LL.M.**, Associate at Loyens & Loeff Luxembourg and lecturer in the field of Private International Law at the Centre Européen Universitaire in Nancy, France. Previously legal secretary at the Court of Justice of the European Union. Author of publications in the field of State Aid law.

**Prof. Dr. Bettina Heiderhoff -** since 2013 professor for Private International Law, Transnational Litigation and for German Civil Law at the University of Münster, Germany. She also is director of the Institute for German and International Family Law and Co-director of the Centre for European Private Law (CEP). From 2006 until 2013 she held a chair at Hamburg University. She took her qualifications at Leipzig University and is specialised in EU Consumer Law, German and International Procedural Law and in Family Law. She is the founder and coordinator of PEPP.

**Joanna Kolber** is admitted to the Brussels bar and works in the litigation and arbitration department of Strelia (Brussels). Her areas of practice cover diverse commercial disputes, with a particular focus on international trade and services law matters. She also specializes in private international law.
